



#### Brothers and Sisters of Local 387,

I would like to thank everyone for all your hard work and dedication to Local 387 in 2019 and wish everyone a Happy New Year! I am confident that 2020 will bring joy and happiness to all of our members and their families and strength and solidarity to our local! We were extremely busy last year with our general election, national contract negotiations and voting, preparing for a possible strike, and all of our annual parties and picnic. Luckily our UAW GM brothers and sisters took on the fight to give our members a better standard of living by striking against the company for 40 days. We are very thankful for the sacrifice that they made to give our members a better contract for the next four years. Our Ford national contract was recently ratified and in any contract negotiation it is impossible to get everything asked for but overall there was progress made to achieve key gains and maintain previous negotiated benefits. Over \$6 billion was invested into 19 Ford facilities in the United

States creating or retaining over 8500 jobs for Ford UAW members. That was more product in the US than both GM and Fiat Chrysler. Active full-time membership was given a \$9000 signing bonus as well as other bonuses and raises throughout the contract, temporary employees now have a "paved road" to permanent employment, and ALL permanent active members will achieve top pay by the end of the contract. This was a huge success in winning back some of the concessions that we made back in 2007 and a future road for our members to once again have equality throughout our membership! We were also able to maintain our healthcare benefits which was a huge win as healthcare costs rise every year. Woodhaven Stamping made significant progress in this contract by eliminating the "Table 4" workforce that was negotiated in the last contract which stated that our WSP members would be lumped in with the Rawsonville and Sterling plants and new members would only be able to max their pay out at around \$19/hr. Not only was this language completely eliminated in the new contract and our hard working Local 387 members can now achieve top pay by the end of the contract but WSP also achieved \$40 million in new product by gaining Mustang work from FRAP. As a result of this all of the temporary workers were recently put on as full-time employees and we were also able to hire many more employees that were temporary workers at Dearborn. Woodhaven Forging members were able to maintain the work that they currently have. These are some of the gains in this contract but as I said before it was not everything that our negotiators were asking for. Hopefully we can build off this in four years and get some of the other resolutions in our next contract!

Thanks to everyone that helped with our Toys for Tots gate collection at WSP by either helping to collect or by giving generously to kids in need so that they were able to have a better holiday this year! Together we raised

### Hard Labor

January 21, 1946: 750,000 steelworkers walk off the job, joining what would become known as the Great Strike Wave of 1946. The post-World War II strike wave was not limited to industrial workers; there were more strikes in transportation, communication, and public utilities than in any previous year. Largely, a result of tumultuous postwar economic adjustments. With 10 million soldiers returning home and the transfer of people from wartime sectors to traditional sectors. Much of the protests were for better pay and working hours, with the rest being for discipline, company policies or firings. By the end of 1946, more than five million American workers were involved in strikes, which lasted on average four times longer than those during the war. They were the largest strikes in American labor history.

- 174,000 electric workers (January 1946)
- 93,000 meatpackers (January 1946)
- 750,000 steel workers (January 1946)
- 340,000 coal miners (April 1946)
- 250,000 railroad engineers and trainmen nationwide (May 1946)
- 120,000 miners, rail and steel workers in the Pittsburgh region. (December 1946)

February 11th 1937: White Shirt Day: The anniversary of the brave men and women who, in 1936-37, created the recognition of the UAW for the first time in the sit down strike against General Motors in Flint. The first few weeks after the settlement of the strike brought a predictable chaos to the plants. Since the success of the strike had created an unprecedented situation, nobody had a clear idea of what the new relationship between labor and supervision was supposed to be. Nevertheless, the new union locals got

busy electing officers, setting up grievance procedures, and signing up members. Now that the overriding fear of belonging to the union was gone, this last task was relatively easy. Inside the plants, wildcat strikes occurred on a daily basis in various departments until the union disavowed them. Most importantly, though, some truly dangerous and exploitative working conditions were banned, such as poor ventilation, hazardous machine work, and unpaid overtime. Additionally, wages rose in nearly every department. Each year on White Shirt Day men and women throughout the UAW wear white-collar attire traditionally donned by management to remember the sacrifices and victories of our Union Brothers and Sisters.

March 7,1932: The Ford Hunger March, sometimes called the Ford Massacre, was a demonstration by 3,000 to 5,000 unemployed auto workers in Detroit, which took place during the height of the Great Depression. Marchers carried banners reading "Give Us Work, "We Want Bread Not Crumbs", and "Tax the Rich and Feed the Poor". The march started in the city and ended in Dearborn where police attempted to stop the march by firing tear gas into the crowd, and began hitting marchers with clubs. One officer fired a gun at the marchers. The unarmed crowd scattered into a field covered with stones, picked them up, and began throwing stones at the police. The angry marchers regrouped and advanced nearly a mile toward the plant. There, two fire engines began spraying cold water onto the marchers from an overpass. The police were joined by Ford security guards, and began shooting into the crowd. Marchers Joe York, Coleman Leny and Joe DeBlasio were killed, and at least 22 others were wounded by gunfire.
